Privacy notice ex art. 13 Legislative Decree 196/2003

As established by the legislation on the protection of personal data (European Data Protection Regulation - EU Reg. 679/2016) SC Sviluppo chimica S.p.A., hereinafter SC, also in the name and on behalf of the Federchimica System (Federchimica, Accademia S.p.A. and Centro Reach S.r.l.) with registered office in Milan, via Giovanni da Procida n. 11, pursuant to EU Regulation 679/2016, Data Controller, wishes to inform you of the following:

Purpose of the Processing

The information that concerns you will be used to stipulate the contract, to fulfil the contractual obligations, to carry out all the activities necessary or useful for the execution of the existing contractual relationship and for the fulfilment of the connected legal obligations also of a fiscal or accounting nature.

Processing methods and storage time

Data processing will be carried out, with or without the aid of electronic instruments, in accordance with principles of correctness, lawfulness, transparency, so as to protect the confidentiality and rights of the data subject at all times in compliance with the provisions of current legislation

The data will be managed by the persons in charge of the commercial and administrative areas by electronic and paper means, according to methods strictly instrumental to the pursuit of the indicated purposes

The data will be kept, in compliance with the provisions of the applicable legislation, for a period of time not exceeding that necessary to achieve the purposes for which they are processed.

Rights of the data subject
